OTHER REQUIREMENTS UPON SUBMISSION OF OFFICIAL ENTRY FORM VIA EMAIL

1. Typewritten short write-up of Painting (max 150 words), English or Pilipino.
2. Photo of Painting at 300DPI (high resolution) **without Artist's Signature**
 - 8 x 12 - for the 24" x 36" painting
 - 12 x 12 - for the 36" x 36" painting
3. Attach 3 Photos of Painting while work-in-progress at the following stages:
 - 1st picture of work at 25% accomplishment with proof of date (e.g. newspaper article with date beside the painting and painter)
 - 2nd picture of work at 50% accomplishment with proof of date
 - 3rd picture of work at 75% accomplishment with proof of date

**any digital alteration or photoshop of the painting automatically disqualifies artist from the competition
4. Scanned copy of Valid Government-Issued ID (GIID) with Photo & Signature, as proof of age and citizenship, e.g. Birth Certificate, Passport, or any valid GIID showing birthdate and citizenship of the participant.

TERMS AND CONDITIONS

If qualified as a Finalist, Artist agrees that ;

1. BDO / SM / ZCME (the "Group")

- Can perpetually display artworks in public areas and social media with no extra compensation to the artist.
- Can perpetually use artworks in publicity and marketing materials of BDO, SM, and ZCME.
- Will own the artworks of the winning entries (for 1st, 2nd, and 3rd Prize winners), artworks automatically become the property of BDO in exchange for the cash prize received by the artist.
- Will have absolute right of BDO to give the winner's original artwork to a donor and donate proceeds to ZCME in full.
- Will grant absolute right to BDO / SM / ZCME to reproduce and distribute or sell images of the artwork in any of their marketing activities.
- Will grant unconditional right to BDO to give the Finalist's artwork to a donor, 50% of proceeds will be given to the artist and the balance of 50% donated to ZCME in behalf of the artist.
- Can continue to offer the artwork in galleries, public areas or virtually in the Groups, various social media platforms for 1 month after the last day of the Art exhibit to interested donors at a pre-determined price set by ZCME / SM/ BDO.
- Will be allowed to offer the unclaimed artwork after the selling deadline (i.e. 1 month after exhibit), 100% of proceeds donated to ZCME.
- Can withdraw the finalist's name and artwork in the exhibit and in its list of finalists and winners on grounds of plagiarism.

2. Finalist must submit actual painting in Stretch Canvas or Exhibit Stretch (NO FRAME), must have string at the back ready for hanging.

3. Along with the actual artwork, finalist must also submit hardcopies of her :

- Valid Government-Issued ID
- Signed Certificate of Authenticity
- Signed Agreement of the Terms and Conditions of the Competition

4. Artist must affix her signature at the back of the painting. Signature in front will not be accepted.

5. RETRIEVAL OF ENTRIES

After the 1-month period from the last day of exhibit, artist can opt to **(CHOOSE 1 option only)**:

- Retrieve the artwork at her own expense within 1 month.
- Entrust to the Group for another 3 months for possible donors (at 50/50 sharing with ZCME). If no donations have been made on the artwork after this period, artist to retrieve the artwork at her own expense 1 month after.

Unclaimed works after the set deadline will be automatically owned by ZCME which will be given absolute right to dispose and use the proceeds in full as a donation of the artist to ZCME.
